- 1. REGARDING REVISIONS (INCREASES) AND ESTABLISHMENT OF POTABLE WATER, IRRIGATION WATER, WASTEWATER AND RECLAIMED WATER CAPACITY FEE CHARGES.**

CHAIRMAN OF THE COMMISSION OPENS THE FINAL PUBLIC HEARING BY ROLL CALL.

UC LEGAL COUNSEL READS THE NOTICE OF PUBLIC HEARING AND PROPOSED RESOLUTION BY TITLE ONLY.

CHAIRMAN THEN ASKS FOR ANY COMMENTS FOR OR OPPOSED TO THE REVISIONS (INCREASES) AND ESTABLISHMENT OF POTABLE WATER, IRRIGATION WATER, WASTEWATER AND RECLAIMED WATER CAPACITY FEE CHARGES.

(JAKE HICKSON EXPRESSED OPPOSITION TO THE FEE INCREASES AND CREATION OF AN IRRIGATION CAPACITY FEE, ALSO REPRESENTED THE VOLUSIA HOMEBUILDER'S ASSOCIATION'S OPPOSITION OF SAME. REITERATED MANY OF HIS COMMENTS MADE DURING THE PRIOR PRELIMINARY PUBLIC HEARING ON 11-21-16)

(PAUL RECHICHAR EXPRESSED OPPOSITION AND SUPPORT OF JAKE HICKSON AND TALKS WITH VBIA, FEES WILL AFFECT UPCOMING DEVELOPMENTS. BELIEVES MANY CUSTOMERS MAY REVERT TO WELLS IN LIEU OF PAYING CAPACITY FEE AND RATES FOR POTABLE WATER IRRIGATION)
