Notes:

The Electric System Change in Net Assets increase of 58% is due to higher income from Operations, primarily due to higher revenues, offset by Capital Contributions associated with Mullinax Ford and Promenade Park in the prior year.

The Water System Change in Net Assets decrease of 114% is due primarily to Capital Contributions associated with Mullinax Ford and Promenade Park in the prior year, as well as, write-off of water assets deconstructed at Sugar Mill and decommissioned assets at the N. Loop. The Reclamation System Change in Net Assets decrease of 8% is due primarily to write-off of wastewater assets deconstructed at Sugar Mill.
