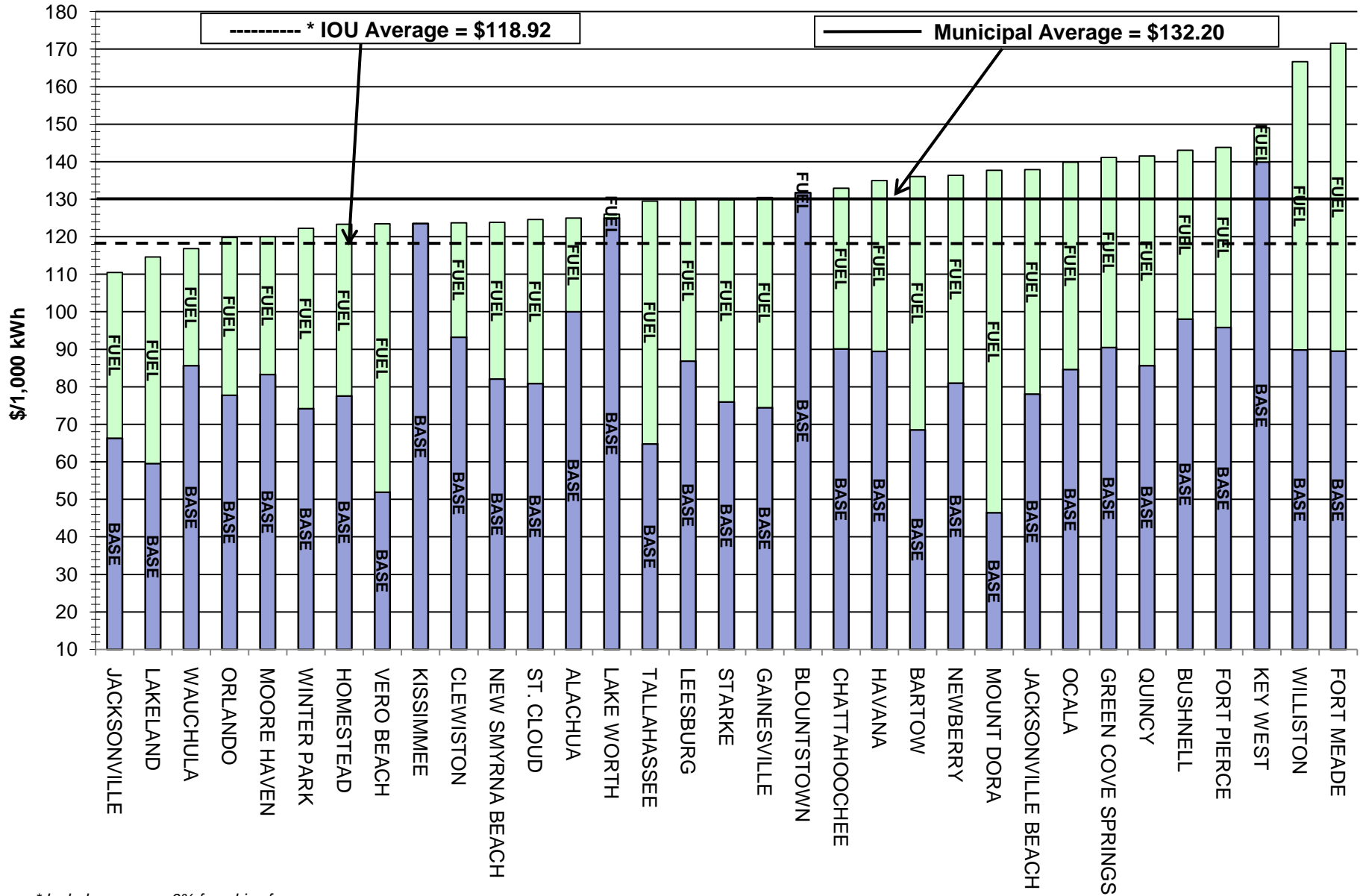
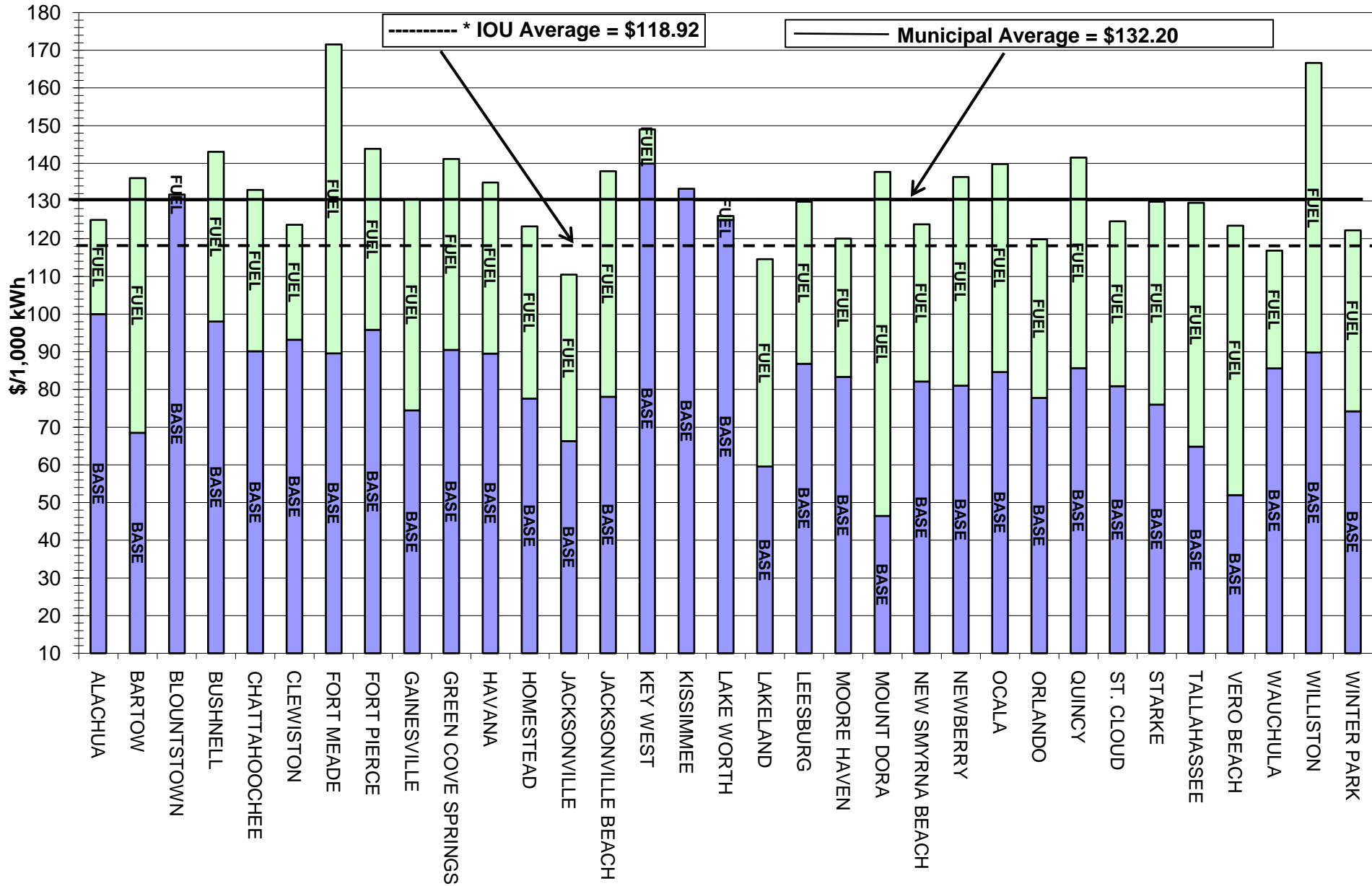


Lowest to Highest Residential Bill Comparison, March 2010
