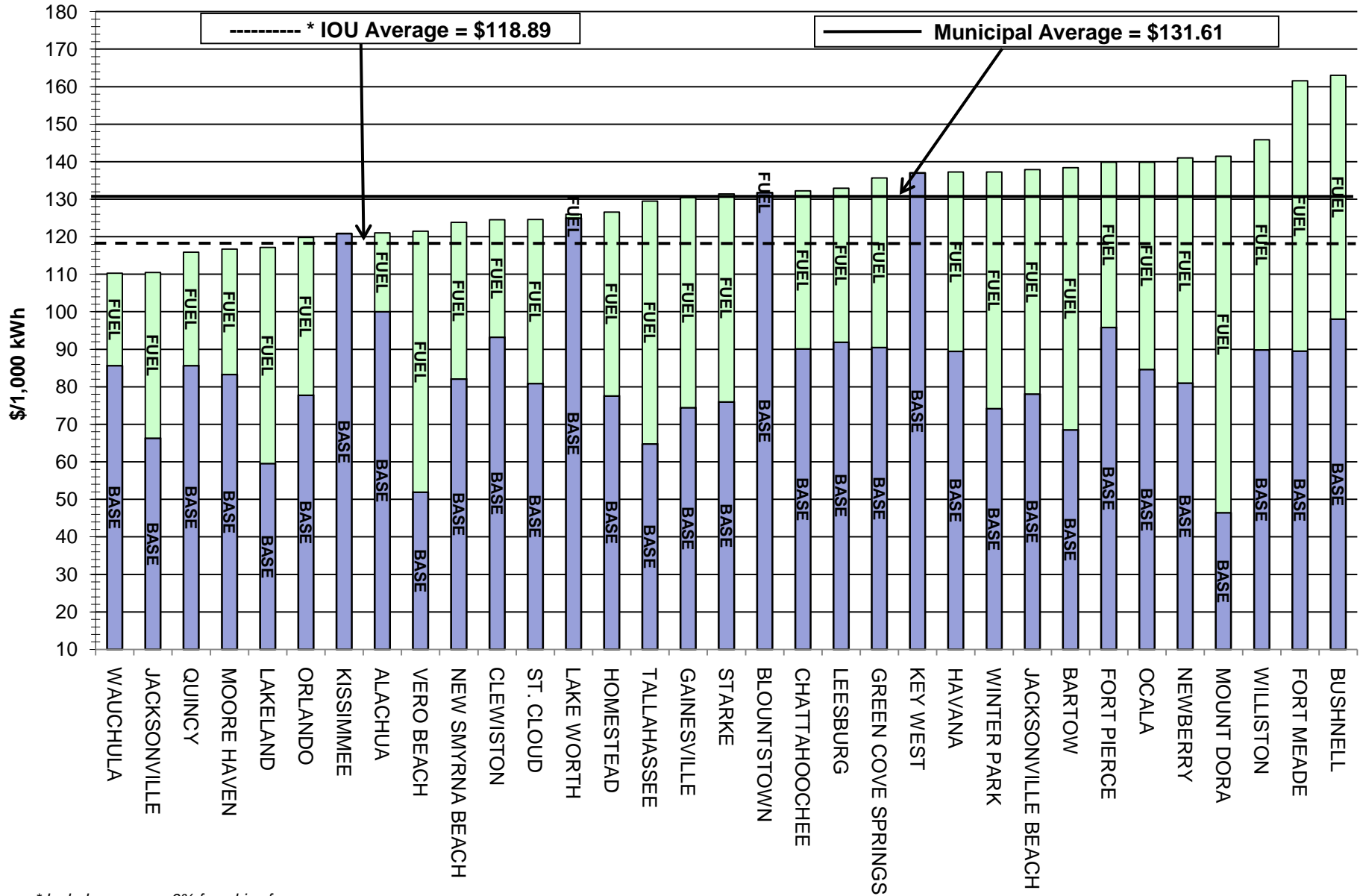
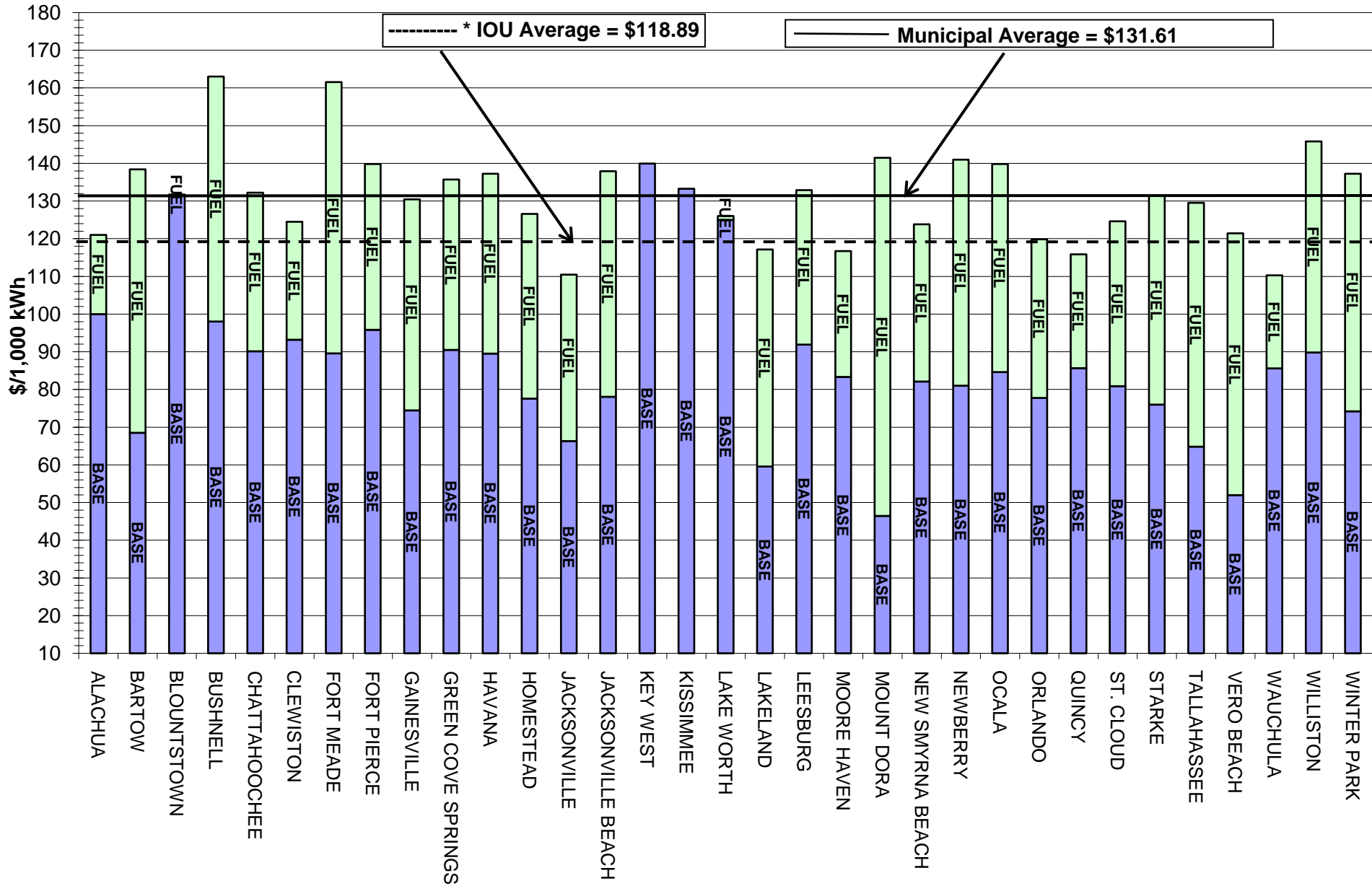


Lowest to Highest Residential Bill Comparison, May 2010
